### RESPONSIBILITIES OF PARTY-II:

1. To enhance the quality of education imparted by incorporating the mutually agreed suggestions made by Party-I.
2. To implement the suggestions made for Curriculum Design and revision for its B.Tech programs run by the Party-II after due deliberations.
3. To offer guest lecturers for the benefit of the staff and Engineers of Party-I on mutually agreed terms.
4. GCET to encourage faculty and students to actively participate in FDP and training programs driven jointly.
